4. One Tournament Committee Member shall be stationed at each of the selected holes at all times during the tournament.
5. Certification of achievement shall be made by the Tournament Committee Member stationed at the hole, the successful participant and the Golf Course Secretary.
6. Score cards shall be completed and submitted with the above-mentioned certification of achievement.
7. Once a Hole-in-One is made, the contest is over. The policy limit will not be reinstated, unless otherwise indicated.
